

CUHK Graduation Gown Rental Agreement

2026

Before registration, please read the following rental agreement carefully:

A. Rental Agreement (Bachelor and Master Graduation Gown Sets)

By stating agree on the gown registration rental form, I hereby agree and acknowledge that I will be subjected and bounded by the following terms of use and conditions:

Payment

· **Total Cost:** HK\$600 (includes a HK\$100 rental fee for 2 months* plus a refundable deposit of HK\$500)

· **Late/Extension Fee:** HK\$100 for every 7 days (every 7 days charged as one unit)

For store pickup, you pay at the store using AlipayHK, Payme, FPS, or Cash. For deliveries, you pay using this form.

* The rental period is **2 months**. For example, if you rent on the 3rd of October 2026, you will need to return the gown set on or before the 3rd of December 2026 to avoid any late charges. Similarly, if you rent on the 15th of November 2026, you should return the gown set on or before the 15th of January 2027 to avoid any late charges.

- For graduates collecting their academic dress at TYG outlets, the rental start date is the date the academic dress is received.
- For those using **courier services**, the rental start date is **defined by the submission date of the registration form**.

* Please note that if you rent from December 29th to 31st 2026, the deadline will be on 1st March 2027.

To avoid late charges, graduates must return the rented graduation gown set on or before the 2 months rental period. **To avoid disputes, students are responsible for the calculation of their own return dates according to the above calculation.**

Late/Extension fee (HK\$100/7days; every 7 days as one unit to charge the applicable fees)

If the gown was found damaged, damage fees will be charged as per below:

	Removable Stains	Irreversible Damage
Gown	HK\$50-\$100	HK\$200
Hood	HK\$30	HK\$150
Hat and Tassel	HK\$30	HK\$150

The whole or part of the deposit may be forfeited for offsetting the damage charges or late or extension fee, but the service provider may not request additional payments from the graduates. The remaining amount of the deposit after forfeiture (if any) should be refunded to the graduates within 2 months after the forfeiture.

If the graduate cancels the pre-applied gown rental service, TYG will refund all the payments made by such graduate (including the rental fee and deposit) within 30 days after such graduate submits service cancellation request or after the day of the last congregation of that academic year, whichever is earlier.

Gown defects, if any

Please note for any defects in gown items, TYG can exchange the item so long as the damage isn't manually / willfully committed; e.g., broken buttons. Please also be aware of the sharp pin that binds the button at the top of the mortarboard because if the button is broken off, the pin will be exposed and may cause injury. TYG holds no responsibility if the user is harmed due to such incidences. Do come back to any outlet (during office hours) for exchange.

B. Rental Agreement (Honorary and Doctoral Graduation Gown Sets)

By stating agree on the gown registration rental form, I hereby agree and acknowledge that I will be subjected and bounded by the following terms of use and conditions:

Payment

- **Total:** HK\$1300 (rental charge HK\$300 / 2 months and deposit #HK\$1000).

For store pickup, you pay at the store using AlipayHK, Payme, FPS, or Cash. For deliveries, you pay using this form.

* The rental period is **2 months**. For example, if you rent on the 3rd of October 2026, you will need to return the gown set on or before the 3rd of December 2026 to avoid any late charges. Similarly, if you rent on the 15th of November 2026, you should return the gown set on or before the 15th of January 2027 to avoid any late charges.

- For graduates collecting their academic dress at TYG outlets, the rental start date is the date the academic dress is received.
- For those using **courier services**, the rental start date is **defined by the submission date of the registration form**.

* Please note that if you rent from December 29th to 31st 2026, the deadline will be on 1st March 2027.

To avoid late charges, graduates must return the rented graduation gown set on or before the 2 months rental period. **To avoid disputes, students are responsible for the calculation of their own return dates using the above calculations.**

Late/Extension fee (HK\$200/7days; every 7 days as one unit to charge the applicable fees)

If the gown was found damaged, damage fees will be charged as per below:

	Removable Stains	Irreversible Damage
Gown	HK\$150-\$200	HK\$600
Hood	HK\$100	HK\$200
Hat	HK\$50	HK\$200
Tassel	HK\$100	HK\$100

The whole or part of the deposit may be forfeited for offsetting the damage charges or late or extension fee, but the service provider may not request additional payments from the graduates. The remaining amount of the deposit after forfeiture (if any) should be refunded to the graduates within 2 months after the forfeiture.

If the graduate cancels the pre-applied gown rental service, TYG will refund all the payments made by such graduate (including the rental fee and deposit) within 30 days after such graduate submits service cancellation request or after the day of the last congregation of that academic year, whichever is earlier.
